It is in the best interest of the Town and its citizens to consider alternate funding options not considered in the staff report to Council to pay for th Options may include finding surplus by creating overlap in the 2019 Capital Budget, evaluating capital cost savings of the spray through reduction of dead tree capital budget, evaluating newly awarded 2020 grants as a means to reallocate known 2020 capital budget requests, etc Ideally, a program that is initiated by the Town should be funded by the Town and a funding strategy should be developed in advance of action.
