Key points of my deputation are as follows: <b>(Written presentation must accompany the request)</b> <u>Light pollution is increasing rapidly</u> <u>IF creates risks to human health, security and safety, ecosystem functions</u> <u>and wildlife, and it's a waste.</u> <u>Control is relatively easy, following simple principles, and usually saves money.</u> <u>A policy would reduce negative impacts and lead to a better night environment.</u>
