4.1 Presentations

4.1.1 COVID Update - Community Emergency Management Co-Ordinator

The Community Emergency Management Co-Ordinator, B. Lymburner provided a COVID-19 update relating to statistics, as well as the recent escalation to the Orange category for the Niagara Region. He reviewed some of the implications of the Section 22 Order by the Medical Officer of Health, and other requirements that are newly required. He suggested that we will move past the education component into an enforcement approach on a Region-wide basis.

The Treasurer, T. Quinlin, reported on the Phase Two COVID-19 funding application that has been submitted by the Town, and summarized the expected budgetary shortfalls due to the pandemic. Ms. Quinlin also

highlighted the mitigation measures undertaken by the Town and Library throughout this pandemic period.
