ACO returned to Jennifer's door with "OAKLEY"S muzzle order and a by-law violation notice- informing Jennifer of a run at large, and failing to obtain dog tag/license by-law infractions.

ACO started to explain muzzle order and appeal process and Jennifer stated that "she could read" and shut door in ACO's face again.

#### Statement – Dog Attack

Monday December 7, 2020, approximately 3:30 p.m. I was walking a friends dog, as I often do, this friend is my ex-partner, I left Balfour Street, heading towards Canboro Rd, proceeded right down Canboro Rd to Maple Street, turned right on Maple Street to Sandra Drive, right at Sandra Drive, we were coming along the sidewalk on Sandra Drive. The house address 1191 Maple Street (corner of Maple and Sandra Drive) there were two vehicles (SUV and a truck) and a mobile home in the driveway. Phoebe (Jack Russell) and I were coming down the sidewalk and out behind the mobile home a large dog (longer hair, blonde/yellow in colour, not a breed I am familiar with) attacked, came out from behind the mobile home. Vicious, full teeth, gnarling, grabbed Phoebe by her coat (thank goodness, coat protected the skin) - I freaked out, started shouting, panicking, I grabbed Phoebe by the leash, pretty sure she was off the ground as I tried to get her out of harm way. My screaming seemed to scare the dog enough to back off, for a second, then the dog came back at Phoebe full teeth, going after her again, I freaked out more, screamed more, panicked more, I heard a faint call from the back yard of the house, the large dog ran off, I stayed on the sidewalk as I did not want to approach anyone on the property, staying off the dog's boundaries/property fearing that would make it more aggressive - especially when I looked around the mobile home to see who was outside of the house, I saw it was a young boy (9 or 10 years old), I did not want to make the dog more aggressive than it was thinking I was going to approach the young boy. I yelled to the boy, angry, 'who is responsible for this dog' - think I yelled the question twice. The young boy yelled back 'it is an electric fence' - I yelled back 'it is not working' and then he disappeared into the house. I waited, thinking for sure the owners of the dog would come out to make sure we were okay, or at least check to see what all the yelling and panicking was. Nothing. Nobody bothered.

I walked Phoebe back to Balfour Street, sent a text to let him know what happened and how upset I was, I gave him the address of the house where the attack happened and let him know I was going to do something, report it, whatever one does when your dog is attacked by an irresponsible dog owner. Was very upset, on his way home from work, he stopped at 1191 Maple Street and a young boy and a man were playing hockey outside, got out of his car and asked 'what is going on, your dog attacked my dog'. The owner replied 'my dog does not have a mean bone in his body', 'I just have to turn up the electric fence' – no concern, no apology, did not ask for details, nothing.

Please advise if you need any additional information. Thank you for reviewing and working to keep our neighborhoods safe from irresponsibility and a lack of concern for neighbours safety.

(1)	Every owner shall not permit the dog to be on any streets or in any public place or any other place that is not owned or controlled by the owner unless the dog is on a substantial chain or leash not exceeding 1.5m in length and muzzled in a manner that will not cause injury to the dog or interfere with its vision or respiration, but will prevent the dog from biting another animal or human - Sec. 8 (d)(1)
(2)	At all times while the dog is on the premises owned or controlled by such person, keep the dog securely confined indoors or in an enclosed pen or other structure, of minimum size five feet by ten feet, capable of preventing the entry of children and other animals and adequately constructed to prevent the dog from escaping - Sec. 8 (d)(2)
(3)	Conspicuously display a sign on his/her premises warning that there is a dangerous dog on the property - Sec. 8 (d)(3)
(4)	So confine said dog that allows persons who have lawful entry onto the premises of the dog owner to have such entry without fear of attack by said dog - Sec. 8 (d)(4)
(5)	Allow an officer to inspect such pen or other structure or to make whatever inquiry is deemed necessary to ensure compliance with the provisions of this by-law - Sec. 8 (d)(5)
	Notify the poundkeeper immediately if a dangerous dog is loose, unconfined, has attacked another animal or human

Notify the poundkeeper immediately if a dangerous dog is loose, unconfined, has attacked another animal or human
or has died or has been sold or given away. If the dog has been sold or given away the owner or harbourer shall provide the poundkeeper with the name, address, and telephone number of the new owner - Sec. 8 (d)(6)

Failure to comply with the above notice will result in fines or a summons to Court and/or a hearing under the Dog Owners Liability Act where a judge may place more restrictions on the dog or order it destroyed.

Dear Valued Town Councillors, Clerks, and Administrative Staff,

My name is Jennifer Irwin and I have been directed to you by Halee Braun, as to how we can navigate the appeal process with the Town of Pelham.

In June of 2018 we brought home our second beloved golden doodle by which we had hand chosen for temperament. We chose her based on a set of criteria in hopes that she would become a Diabetic Alert Dog for our daughter Katherine who had been recently, two months prior, been diagnosed with Type One Diabetes. Our daughter, who was ten at the time, took her to training, and has been her main handler. Together, they completed the first round of training with Dave Mc Mahon and their bond is special.

We have many letters of support from our large circle of friends, neighbours and family who have grown to love Oakley through the two and a half years she has been with us. These testimonies also speak to our character as animal owners, and include letters from our long time neighbours who have not ever seen her cross the invisible fence line.

On Monday December 7th, a man showed up in our driveway and initiated a heated conversation with my husband explaining that our Oakley had crossed the electric fence line, and attacked his Jack Russell dog that his wife was walking. We were immediately responsive to the situation and very concerned because she has not crossed the line before in the two and a half years that we have had her and she has not ever been aggressive to people, kids, babies, or animals. Moreover, previously to Oakley, we had another Golden Doodle who never crossed the line, for the five years we had the fence. We asked this man if there was a vet bill, or any way to rectify the situation and the man threatened our dog, and explained that there was no wound on his jack russel because the dog was wearing a sweater jacket. When we asked our son, who was in the driveway when the alleged happened, our nine year son explained that a woman had yelled at him aggressively while he was playing hockey about our dog. When the attack happened, our son would have been 20 meters from where this happened. His fault,

which he has been spoken to regarding, was that he did not come and get a parent. Alternately, I wonder why the woman wouldn't seek an adult also.

When this was brought to our attention, we immediately came in and purchased a new fence and collar to mitigate any faults that the current one might have developed. On Thursday evening, the SPCA showed up with a Muzzle Order which prohibits our beloved Oakleys freedom and labels her a vicious dog. **Specifically, we were presented with the By-Law No. 97-2010 and are requested to complete orders 1,3,4,6 by December 17, 2020 at 9 am. Orders 2 and 5 are to be completed by December 27th 2020 at 9am.** We would like to appeal this order as we feel that the evidence compiled against us is lacking. There was no vet bill, or damage to the animal. We have many letters from the community that speak to our dog's character and our family dog handling skills. We feel that if Oakley was aggressive and attacked, our son would have noticed, sought help and reacted, as this is out of character for our dog. On the off chance the fence was defective, we have taken measures to correct this and will ensure that it does not happen again. Ever. We are struggling with condemning her for a vicious attack that left no marks and has no witnesses other than the woman who was walking the dog. We are requesting a formal appeal, to ensure that a resolution can be met that will enable Oakley to have a quality of life and some freedom.

Please let me know what is needed from this point on to see this important process through.

To Whom it May Concern:

Paul and Jen Irwin became friends of ours not long after we moved to Fenwick in 2013. We share a love of the outdoors and have children close in age, and over the years have enjoyed many barbeques, child play dates, hikes, camping trips, horse back riding events and even dog sledding excursions. Almost always the Irwin's dogs have been a part of our backyard barbecues and outdoor activities, playfully interacting with our four children as well as our own animals including our three dogs ( ( a border collie, whippet, and King Charles Cavalier), cats and horses. Whenever we get together there is often a lot of activity and noise with children running, shouting and playing. Despite this, we have never had an incident where the Irwin's dogs ( Oakley, Winnie, or the late Neo) have acted aggressively or caused injury to a person, including children, or one of our animals. As such, it came as such a surprise to learn of the allegation that Oakley had "viciously attacked" a small dog passing by the Irwin's property on leash. An unprovoked attack seems completely out of character and inconsistent with our experience of Oakley as a family and our knowledge of the Irwin's as responsible dog owners. To illustrate:

**Oakley is not an ordinary dog** and the Irwin's are not your typical dog owners. Oakley was carefully chosen by Jen and Paul (after much research and preparation) to be a companion dog and emotional support for their eldest child who had been diagnosed with diabetes at the age of eleven. As a psychotherapist working in the area of animal-



assisted therapies, I have come to appreciate the tremendous impact that the humananimal bond can have on a child 's health and development. Jen and Paul also have this appreciation and anticipated the positive impact that Oakley could have on their family and their daughter's life, post diagnosis. As a puppy, the Irwin's made sure that their daughter helped to train Oakley and complete puppy training through the Dave McMahon dog training school. Since then, I have witnessed the special bond between Oakley and their daughter, including the positive effect that the training, care and companionship of Oakley has had on her confidence, mental health and wellbeing. On any given day prior to this allegation, Oakley could be seen in the Irwin's fenced (invisible) yard happily playing with the Irwin's children or watching them as she lay in the sun. When she wasn't outside, she was a part of the Irwin's indoor activities, always closest to the action. In short, Oakley can be best described as an intelligent and exuberant family dog that loves children and playing with other dogs like mine. She eagerly greets anyone who comes to the door with barks of joy, playful licks and boundless energy. She is without a doubt a delightful dog with a special role in the Irwin family.

It has come to our attention that one of the dogs in our neighbourhood, Oakley, owned by Paul and Jenn Irwin who live at the corner of Sandra Drive and Maple Street in Fenwick, has been accused of vicious behavior.

We have a small, 12-pound cockapoo which we walk two or three times a day past the Irwin house. Oakley has been outside on numerous occasions and has never been aggressive toward our dog. In fact, they wag their tales and sniff each other without incident.

Our house is across the road from the Irwin's and we are often outside where we can observe people frequently walking through our neighbourhood. The sidewalk beside the Irwin's house experiences a high number of dog walkers and we have not observed any aggressive behavior from Oakley.

#### Paul and Jennifer Irwin re Oakley

#### Hi Paul and Jen,

I was shocked to hear the news about Oakley. I tried to send an email directly to the Welland and District Humane Society but I was unable to find that kind of contact information on their website. I would have called but I prefer that there be a written record of my communication.

Recently you shared that the Welland and District Humane Society appeared at your home with a complaint about Oakley, described as a vicious attack on another dog (a Jack Russell Terrier) They indicated that they intended to issue an order against Oakley as a vicious dog, a dog that would be required to wear a muzzle at all times and a requirement that Oakley is leashed and confined to a pen.

In the seventeen years that I have known you, I cannot recall a single moment where you have been people who did not take full responsibility for yourselves and your pets. You have always been conscientious community members and this remains my observation present day. When you got Oakley two and a half years ago I know you intended to train her as a support dog for your daughter Katie who was recently diagnosed with juvenile diabetes.

To imagine that any circumstance would arise that would reveal Oakely to be anything less than a child loving, gentle dog is beyond comprehension. Even at times when our whole staff has been present in your home Oakley was a friendly quiet dog.

It is my understanding that a situation arose where Oakley ran up to a woman and her Jack Russell Terrier while they were out walking. While it can be upsetting to be greeted by an unfamiliar dog, a competent dog owner would have easily assessed Oakley as a non-threat. To learn that the report to the Human Society was made by a third party and that there was no physical evidence of harm to the Jack Russell Terrier, it confounds me that a society whose's mandate is to protect animals and educate the public would take such an ill-considered approach in this instance. To deem any animal vicious would certainly require a thorough investigation of the situation and some form of evidentiary support.

Looking at the mission, vision, and values stated by the Welland and District Humane Society on their website, it seems that they have contravened their mandate to protect all animals from harm. Certainly, a proclamation of Oakley as a vicious dog and a life sentence to be muzzled and confined is in no way protecting her rights to be treated fairly or to protect her well being.

I am dismayed by the Welland and District County Humane Society's disregard for the protection of Oakley from a report given without evidence and a measure of assessment of the validity. The opportunity to educate the public is not clear and the disregard for your record of being very responsible and respectful pet owners is also neglected.

I would like to public to be aware of these circumstances and to have the opportunity to address the appropriate use of the mandate of the Welland and District Human society. Please let me know if I can

support you via social media to bring this situation to light. Perhaps cooler heads will prevail and it will not be necessary to take that step.

I wish you the best in a quick resolution to this unfortunate misunderstanding.

### Being a by-law to adopt, ratify and confirm the actions of the Council at its special meeting held on the 24th day of February 2021.

WHEREAS Section 5 (3) of the Municipal Act, S.O. 2001, Chapter M.25, as amended, provides that, except if otherwise authorized, the powers of Council shall be exercised by by-law;

AND WHEREAS it is deemed desirable and expedient that the actions of the Council as herein set forth be adopted, ratified and confirmed by by-law;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (a) The actions of the Council at its meeting held on the 24th day of February, 2021, including all resolutions or motions approved, are hereby adopted, ratified and confirmed as if they were expressly embodied in this by-law.
  - (b) The above-mentioned actions shall not include:
    - (I) any actions required by law to be taken by resolution, or
    - (II) any actions for which prior Ontario Municipal Board approval is required, until such approval is obtained.
- (2) The Mayor and proper officials of the Corporation of the Town of Pelham are hereby authorized and directed to do all things necessary to give effect to the above-mentioned actions and to obtain approvals where required.
- (3) Unless otherwise provided, the Mayor and Clerk are hereby authorized and directed to execute and the Clerk to affix the seal of the Corporation of the Town of Pelham to all documents necessary to give effect to the above-mentioned actions.
- (4) THAT this by-law shall come into force on the day upon which it is passed.
