By-law No. 4450(2022)

**Being a by-law to adopt, ratify and confirm the actions of the Council at its special meeting held on the 25<sup>th</sup> day of November 2022.**

**WHEREAS** Section 5(3) of the *Municipal Act, 2001*, S.O. 2001, Chapter M.25, as amended, provides that, unless otherwise authorized, the powers of Council shall be exercised by by-law;

**AND WHEREAS** it is deemed desirable and expedient that the actions of the Council as herein set forth be adopted, ratified and confirmed by by-law;

**NOW THEREFORE** Council of the Corporation of the Town of Pelham Enacts as Follows:

- (1) (a) The actions of the Council at its meeting held on the 25th day of November 2022, including all resolutions or motions approved, are hereby adopted, ratified and confirmed as if they were expressly embodied in this by-law.  
  
(b) The above-mentioned actions shall not include:
  - (I) any actions required by-law to be taken by resolution, or
  - (II) any actions for which prior Ontario Municipal Board approval is required, until such approval is obtained.
- (2) The Mayor and proper officials of the Corporation of the Town of Pelham are hereby authorized and directed to do all things necessary to give effect to the above-mentioned actions and to obtain approvals where required.
- (3) Unless otherwise provided, the Mayor and Clerk are hereby authorized and directed to execute and the Clerk to affix the seal of the Corporation of the Town of Pelham to all documents necessary to give effect to the above-mentioned actions.
- (4) THAT this by-law shall come into force on the day upon which it is passed.
