perpetuating the myths and falsehoods created by this motion and allowing the undermining of the Council, Staff and Professional Consultants of the Town of Pelham to linger, despite overwhelming evidence that the factual material in the motion was false; and

Whereas this action prevented the Mayor for the Town of Pelham from addressing this motion despite the fact that Councillors Barrick and Quirk were in fact allowed to speak to the motion and to allude to impropriety on behalf of the Town of Pelham; and

Whereas the Council of the Town of Pelham believes that this motion is politically motivated and designed to embarrass and attack the Town of Pelham representatives on Regional Council as well as the entire Town Council as a result of stands taken by Town of Pelham Council on various Regional issues; and
